TERMS & CONDITIONS:

1. Eligible bidders, who are on Active Taxpayers list (ATI) of FBR and eligible to supply goods/services to Government Departments, can apply. The tenders shall reach to office of Budget & Accounts Assistant of District & Sessions Judge, Karak on **08-06-2023** at **11:00 AM**, which will be opened on the same day at **12:00 PM** in presence of available and interested bidders or their authorized agents.
2. Quantity of each item in all heads can be increased or decreased as per available budget.
3. The Firm must have Income Tax and GST Number Registration etc.
4. Taxes and others deductions will be made as per rules.
5. 2% of total bid amount i.e Rs. 80,000/- as Earnest Money/Security deposit should be attached with the tenders, in the shape of the call deposit return (CDR), in favor of District & Sessions Judge, Karak. Tenders with Cross Cheque/ Banker's Cheque and without call deposit shall not be entertained. The Earnest Money/Call Deposit Return (CDR) of the unsuccessful bidders, however, shall be returned after approval/finalization of the tender.
6. Firms shall give itself guarantee/warranty of one year with parts in writing on separate stamp paper/bill etc.
7. Delivery period will be 30 days after issuance of Supply Order. Failure in supply of the items within the stipulated period shall entail forfeiture of their Earnest Money/Call Deposit Return (CDR).
8. Agreement, contract, and installation shall be awarded to the lowest bidder (lowest in sum of all items prices) in the above-mentioned specifications as per the satisfaction of procurement committee. (Price shall not be considered per item).
9. Installation shall be made subject to approval of the Technical Committee.
10. The Authority reserves the right to reject any or all tenders with reason according the with KPPRA Rules.
11. Incomplete, ambiguous, and conditional bids shall not be entertained.
12. Bids can be submitted by post or delivered directly in the Office of the Budget & Account Assistant District Judiciary (Headquarter), Karak.
13. The purchase will be made in accordance with KPPRA Rules 2014.
14. Every bidder/firm must submit Technical & Financial quotation (One Envelope Single Stage).
15. The detail of the tender items alongwith bill of quantity mentioned in tender documents. Tender documents and bill of Quantity can be obtained from the Office of Budget & Account Assistant, District Judiciary Karak and is also available on the official website of District Judiciary, Karak.
