**OFFICE ORDER**

In furtherance of jointly agreed proposal, presented by Senior Civil Judge (Admn), Karak; the following Civil Judges/Judicial Magistrates are hereby appointed as Magistrate on Duty (MOD) to receive and dispose of all urgent civil/criminal matters i.e. like stay and bail applications etc, at the District Headquarter, Karak during winter vacations. They are also authorized u/s 17 (4) Cr.PC to receive and dispose of all urgent criminal work (bail applications/superdari), pertaining to this Court as well as the Courts of Additional District & Sessions Judges of District Karak during the period mentioned against their names. Furthermore, by attracting jurisdiction under Section 22 of the Civil Courts Ordinance, 1962, the available senior most Judicial Officer at station is being delegated with powers of performing any of the duties enumerated in Section 21 of the law ibid that may be emergent; till the completion of vacations or until the Office of the District Judge is being resumed.
